#### **Tuition Assistance**

The results of the FACTS evaluation will be provided to the pastor and principal for final decision regarding eligibility.

All applications for tuition assistance must be received by April 30, 2017. Applications received after the deadline may not be considered pending available funding.

## **Meeting with the Principal**

All new students and their parents must meet with Mrs. Alvarez prior to being accepted to St. Pius X School. Please call the office to set up an appointment.
