



## **Age Requirements**

PreK3-call the school office for age guidelines

PreK4- child must be 4 years old on or before September 10<sup>th</sup>

Kindergarten- child must be 5 years old on or before September 10<sup>th</sup>

First Grade- child must be 6 years old on or before September 10<sup>th</sup>

## **Tuition Assistance**

Tuition assistance is available to St. Pius X parishioners. To be considered for tuition assistance you must complete the FACTS Financial Questionnaire for evaluation by the FACTS company. The results of the FACTS evaluation will be provided to the pastor and principal for final decision regarding eligibility.

All applications for tuition assistance must be received by April 30, 2017. Applications received after the deadline may not be considered pending available funding.

## **Meeting with the Principal**

All new students and their parents must meet with Mrs. Alvarez prior to being accepted to St. Pius X School. Please call the office to set up an appointment.

## **Books and Supplies**

3. *Deposit.* I agree to enclose herewith a non-refundable registration fee of \$150.00 per child if received by Feb 15<sup>th</sup> 2017. After this day, the registration fee for returning students will be \$300 per child. This fee shall not apply towards my child's (children's) tuition. **I understand that the Registration Fee is a non-refundable fee and will not be returned to me if I choose to withdraw my child.**

4. *School Advisory Council Policy.* All tuition and fees owed from the prior school year must be paid in full before a student will be allowed to begin the new school year. In addition, all fees required for the new school year must be current before a student can begin classes. If during the school year tuition becomes 45 days delinquent, the parents will be contacted and informed that the tuition must be brought up to date within 10 days. If this is not done, or if specific arrangements are not made with the principal and pastor to bring the tuition up to date within a specific time period, the parent may be asked to withdraw the student from school.

**Progress reports and final transcripts will be marked Incomplete until all tuition and fees are up to date. Access to online information will be blocked.**

5. *Withdrawal of Child Penalty.* I agree to enroll and pay tuition for my child's (children's) enrollment in St. Pius X School for the entire academic school year of 2017/18. In the event I voluntarily withdraw my child (children) from St. Pius X School and transfer him/her (them) to another parochial, private, or public school within Mobile County, I understand that I am still responsible for tuition and fee payment for the entire year. If I am moving out of the city or am asked to leave St. Pius X, I understand registration fees will not be refunded and tuition, should it be paid up front, will be prorated, and the balance returned. I agree to pay the balance of the fees due to the school.

6. *Entire Agreement.* This Agreement embodies the full and final expression of the St. Pius X Tuition Agreement between the undersigned and St. Pius X School. This agreement is a complete integration of the parties' terms and supersedes all agreements previously made between the parties. Any agreement hereafter made between them shall be ineffective to change, modify, waive, release, discharge, terminate, or effect an abandonment of this agreement, in whole or in part, unless such agreement is in writing and signed by the party against whom enforcement is sought.

7. *Arbitration of Disputes.* Any disputes arising out of or relating to this Agreement, performance under this Agreement, or the breach thereof, including all disputes of any nature relating to my child's enrollment and attendance at this school, and including but not limited to the threshold questions of arbitrability and the formation of this arbitration agreement, shall be finally resolved by binding arbitration administered by the American Arbitration Association under its rules, and judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction. The arbitration shall be conducted in the English language in the city of Mobile, Alabama, applying the laws of the State of Alabama. There shall be one arbitrator who shall be selected in accordance with the procedures of the American Arbitration Association. Each party shall pay one half of the cost of the arbitrator. In no event shall punitive damages be awarded by the arbitrator in favor of either party, unless specifically authorized by applicable statute. This provision is continuing in nature and shall remain in force throughout the entire period of my child's enrollment at this school.

By my signature below, I agree to send any and all disputes relating to this agreement, to binding arbitration. I also hereby waive my right to a jury trial if dispute arises in any way relating to this agreement.
